# **Important New HOA Legislation to Know**

HB23-1105 Homeowners' Association and Metropolitan District Homeowners' Rights Task Forces

#### Effective May 24, 2023

This bill establishes task forces to examine issues impacting certain homeowners' rights in Metro Districts and HOAs, including fining practices, foreclosure practices, communications, and document availability. The task forces are to be appointed by August 1, 2023. Notification to owners about the task force is required **before** the task force holds its first meeting. The new law does not say when this first meeting occurs, nor does it mandate how notice is to be sent.

"Pursuant to House Bill 23-1105, signed into law on May 24, 2023, an HOA Task Force is to be appointed by August 1, 2023, to examine issues regarding homeowners' rights and to perform other duties as noted in the new law. Each homeowner association in Colorado is required to notify owners about this task force. If you have questions about the task force, the HOA Information Office (part of the Division of Real Estate within the Colorado Department of Regulatory Agencies) may have additional information."

# It's The Caution **Low Hanging Branches** Trim trees and bushes that overhang your sidewalks!


# **Landscaping Reminders**

Per Aurora code:

Bushes over sidewalks must be cut back six inches from the sidewalk to clear the walkway.

> Plants which have thorns, spines or prickles are not to be planted within four feet of the public sidewalk.

> > Tree branches are to be cut if they hang lower than eight feet over sidewalks and thirteen feet six inches over the street.



# **Design Review Committee**

During May 2023 the Design Review Committee met twice: May 8 and 22nd. At the two meetings the committee reviewed 58 requests. Ten (10) were denied. Of the ten denied, nine were denied for a lack of information (materials, colors, plot plans etc.)

Below are the approved requests. The breakdown may exceed the number of total requests due to multiple projects included on a single request.

- **0** Fencing (Staining)
- **0** Hot Tubs/Hot Tub Screens

- **1** Roofing/Gutter Replacement
- 4 Solar Panels
- Other (patio pavers, greenhouse, rails, storm door)

- O Driveway Surface
- 9 Exterior Painting
- 1 Gazebos/Pergolas/Awnings
- 1 Landscaping (tree replacement, sod replacement)
- **0** Radon Installation
- **0** Storage Containers/Attached Additions
- 3 Waterwise Installation
- 0 Window Replacements

For the calendar year 2023, the Design Review Committee reviewed 108 requests and approved 87 requests.
